Over the last decade, small and young firms in the developed countries have witnessed fast rate of innovation which enabled faster growth and high job creation by these innovative firms. Therefore, for the future economic growth of the developing countries supporting innovative research and creativity at university as well as knowledge based small firms is prerequisite.
